

RIVER RIDGE YOUTH SUPERVISION PROGRAM

Friday and Saturday, 6:00 P.M. until close*

*or at any other time at the discretion of management.

Please note: Youth Supervision Program can be implemented at management's discretion at any other day and time when it is deemed appropriate or necessary by management, security, and or/local authorities.

The program is in effect for the entire property except stores with exterior entrances; including: JCPenney, Belk, T.J.Maxx, and Regal Cinemas*. (See #10 regarding Regal Cinemas).

The program includes the walkways and any corridor leading in to the property. In addition, unsupervised shoppers under the age of 18 will not be permitted to congregate in the parking lot.

The program states:

1. River Ridge visitors under 18 are required to be accompanied by a parent or guardian 21 years or older on Friday and Saturday evenings after 6:00 P.M., or any other time the program is in effect.
2. Security will begin monitoring those entering the center at 6:00 P.M. on Friday and Saturday evenings.
3. Unescorted youth shopping prior to 6:00 P.M. on Friday and Saturday evenings must leave the property by 6:00 P.M. or be joined by a parent or guardian.
4. Unescorted youth will be asked to leave the center after 6:00 P.M. on Fridays and Saturdays, or any other time the program is in effect.
5. Individuals utilizing public or other forms of transportation must schedule their departure time to ensure compliance with the 6:00 P.M. youth/guardian program.
6. Individuals in violation of the Youth Supervision Program or in violation of any posted River Ridge rules that refuse to leave the property when requested to do so by River Ridge security officers may be prosecuted for trespassing.
7. Proof of age will be required if the age of the youth and/or parent or legal guardian is not easily determined. Those whose age cannot be determined and who lack identification will be asked to leave the property.
8. Acceptable identification of a photo ID from a state agency, school, or employer.

9. Youth under 18 working at River Ridge will be permitted to access without parent or legal guardian; proof of work status will be required.
10. Unescorted movie theater patrons under 18 years of age must only use the two mall entrances directly adjacent to the theater.
11. One parent, over 21 years of age, may escort all his/her children.
Additionally, one parent or guardian, over 21 years of age, may escort up to three (3), youths, at least one of the youths must be the children of the parent or guardian.
12. Parents or guardians are responsible for the actions of the escorted youth.
13. Any person violating the posted rules of behavior will be asked to leave River Ridge.
14. If any escorted youth is banned from the property, the adult escort will also be banned for the same period.
