# Code of Conduct

**River Ridge** is private property. In order to provide a safe, secure and pleasant environment, River Ridge requests your cooperation in complying with the following “rules of conduct” to be followed by all patrons.

- 1. River Ridge is for shopping.** Treat others as you like to be treated. Appropriate behavior does not include fighting, harassment, offending others or provoking confrontations or disruptive conduct of any nature.
- 2. Act responsibly. Please refrain from...**
  - Shouting, making loud noises or using indecent language
  - Playing loud music other than what the property provides
  - Defacing, damaging, or destroying any property belonging to River Ridge, its patrons, or its tenants
  - Assembling in a manner which disturbs the public peace
- 3. Allow others to shop safely and comfortably. Please...**
  - Do not block access to store entrances and corridor or parking areas
  - Walk; don't run, skate or skateboard
  - Use our benches and chairs for sitting
  - Do not bring animals and/or pets onto the property except for registered aid animals, such as Seeing Eye Dogs
  - Do not leave animals unattended in parked cars
  - **OPEN CARRY OF ANY WEAPONS ARE NOT PERMITTED ON RIVER RIDGE PROPERTY**
- 4. River Ridge only permits service animals in the areas of its premises that are open to the public. Please scan for full policy details:** 
- 5. Observe all Federal, State and Local Laws.** Use of alcoholic beverages is restricted to designated areas. During regular school hours, excluding lunch breaks, unaccompanied minors will be asked to leave the property.
- 6. Please dress appropriately and observe all health codes and local laws.** Clothing should not be worn which is obscene or offensive in nature. Smoking is only permitted in designated areas.
- 7. Please visit the Center Office to request permission to take photos, videotapes or make audio tapes of or on Center property or store fronts.** Without prior, written permission from River Ridge Management, no such activity is permitted.
- 8. Distribution of literature, solicitation, demonstrations, and special promotions or using the property for any purpose other than shopping is prohibited without prior written permission from River Ridge.** If permitted by law or if you have any questions please visit the River Ridge Management Office for more information.
- 9. When River Ridge and stores are closed, please leave.**
- 10. The Regal Cinemas common area is for the restricted use of theater customers only after River Ridge operating hours.**
- 11. Please do not park or loiter on the property after closing.** Unauthorized vehicles parked overnight may be towed at Owner expense.
- 12. Please follow these Rules of Conduct.** If you do not, we will ask you to leave and stay away for a specified period of time. You may also be subject to prosecution for violation of applicable laws or ordinances.
